**ORDER SUSPENDING
APPOINTMENT OF GUARDIANS**

This matter came before this Court on March 8, 2023, on the Office of the Public Guardian's Petition to Amend Guardianship. Current Guardians Maeann Tedtaotao Cruz and Ernie Guerrero Tedtaotao did not attend and could not be located after attempts by the Court Marshals to serve Court notices. For this reason, the Court preliminarily determines that Cruz and Tedtaotao have failed to perform their duties suitably and are therefore subject to removal. *See* 15 GCA §4501.

The Court hereby gives notice of its intent to terminate Cruz and Tedtaotao as guardians. A removal hearing shall be held remotely on April 12, 2023, at 11:50 a.m., at which time Cruz and Tedtaotao may respond to the issue of their permanent removal as guardians. IT IS THEREFORE ORDERED that the appointment of MAEANN TEDTAOTAO CRUZ and ERNIE GUERRERO TEDTAOTAO as guardians over PETER PAUL GUERRERO TEDTAOTAO is hereby SUSPENDED until further order of the Court. During this suspension, Maeann and Ernie are ORDERED to cease all management of the wards' estate, and to take no further action unless approved by the Court. This ORDER may be served upon all financial institutions and other concerned persons or entities who are expected to comply with this Order.

Issued concurrently herewith is an Amended Order appointing the Office of the Public Guardian, Marcelene C. Santos as interim guardian of the person and estate of Peter Paul Guerreo Tedtaotao. Refer to that Order for further information as to the scope of the continuing guardianship over the ward.
