**AMENDED ORDER SUSPENDING  
APPOINTMENT OF GUARDIAN**

The Office of the Public Guardian advises that Guardian Taniako Pwechar cannot be located and has not actively acted as the guardian for the ward, Jefferson Pwechar. For this reason, the Court preliminarily determines that Taniako Pwechar has failed to perform her duties suitably and is therefore subject to removal. *See* 15 GCA §4501.

The Court hereby gives notice of its intent to terminate Taniako Pwechar as guardian. A removal hearing shall be held remotely on **Wednesday, May 24, 2023, at 11:30 a.m.**, at which time Taniako Pwechar may respond to whether she should be permanently removed as the guardian. Additionally, because attempts to locate the guardian have been unsuccessful, the Court will provide notice of this potential termination by publication on the Judiciary of Guam's website:

IT IS THEREFORE ORDERED that the appointment of TANIAKO PWECHAR as guardian over JEFFERSON PWECHAR is hereby SUSPENDED until further order of the

Court. During this suspension, Taniako is ORDERED to cease all management of the wards' estate, and to take no further action unless approved by the Court. This ORDER may be served upon all financial institutions and other concerned persons or entities who are expected to comply with this Order.
