This specialized training features sessions specific to the veteran mentor coordinator and veteran mentor roles in Veteran Treatment Court which is necessary to enhance and standardize mentor professional development.</p>
<p>Jocelyn M. Roden (Veteran Treatment Court Defense Counsel)</p>	<p>Attorney Roden has been an integral team member in the Judiciary's Veteran's Treatment Court. This training will enhance her skills in dealing with Veterans who have Substance and Mental Health diagnosis, Psycho pharmacology concerns and overall treatment and programs needs.</p>
<p>Ana Maria C.
