This memorandum is intended to report on my attendance at the National Association for Court Management's (NACM) Mid-Year Meeting in Costa Mesa, California from February 4-6, 2024. In addition to the financial support from the Judiciary for attendance at this meeting, I was also the recipient of a scholarship from NACM, which covers, on a reimbursement basis, the cost of the registration fee, lodging for the nights of the conference and \$500.00 toward travel expenses.

The meeting's theme was "Leadership Opportunities and Challenges for our Nation's Courts: Engaging a New and Diverse Workforce." As a condition of my scholarship, I was asked to volunteer time during the meeting; I chose to serve as a session host, which involved introducing a session speaker and moderating questions from the audience. The session I hosted was entitled "Including Asian Americans and Pacific Islanders in DEI Conversations" and its sole speaker was Professor Robert T. Chang, Executive Director of the Fred T. Korematsu Center for Law and Equality at Seattle University's law school. His discussion was more of a historical perspective on the manner in which Asian Americans had been barred to equal access to justice through the various statutory frameworks that have been employed throughout the United States.

From a practical perspective, the two most relevant sessions for me involved data and project management. Specifically, "PHASE: A Practical Approach to Implementation" resonated with me as we navigate the transition to e-Courts and the launch of digital evidence. Most notably for me in this session was that best practice sets out that implementation of a new policy or program should take two to four years.

Another session that was helpful was entitled "Data Visualization and Storytelling." Understanding the Judiciary's emphasis on making data-informed decisions, this session was particularly helpful to me because it provided advice on how to use data to tell the courts' stories to the larger community, including funding bodies and the public that we serve.
