From June 23 to June 26, 2025, I attended the Advanced Administrative Law Course (JS 649) hosted by the National Judicial College in San Francisco, California. This course was specifically designed for experienced judges, administrative law judges, adjudicators, and hearing officers seeking to deepen their understanding of complex legal issues and emerging trends in administrative adjudication.

The curriculum provided a comprehensive exploration of advanced topics in administrative law, including recent constitutional developments, evidentiary standards, judicial ethics, and the integration of technology—particularly artificial intelligence—into adjudicative processes. One of the highlights of the course was a session led by Dean Erwin Chemerinsky, who provided an insightful analysis of recent Supreme Court decisions and their implications for administrative law, including discussions on the Chevron doctrine and the major questions doctrine.

Throughout the four-day training, participants engaged in interactive workshops and peer discussions that emphasized practical applications of legal principles. Topics such as decision writing, judicial review, and access to justice were explored in depth, with a strong focus on maintaining procedural fairness and ethical integrity in administrative hearings. The course also addressed the growing prevalence of virtual hearings, offering guidance on best practices and technological considerations to ensure equitable outcomes.

A particularly forward-looking component of the training involved the role of artificial intelligence in administrative law. The course examined both the opportunities and challenges posed by Al tools in legal filings, decision-making, and case management, with an emphasis on ethical boundaries and transparency.

The training provided valuable insights that are directly applicable to our work within the Judiciary of Guam. I gained a deeper understanding of how evolving legal standards and technological innovations can be integrated into our adjudicative practices to enhance fairness, efficiency, and public trust. The course also reinforced the importance of ongoing professional development and peer collaboration in maintaining high standards of judicial conduct.

I recommend that the Judiciary of Guam consider future participation in NJC programs, particularly those addressing emerging legal and technological issues. Additionally, it may be beneficial to explore the incorporation of Al literacy and virtual hearing protocols into our internal training initiatives.

In conclusion, the Advanced Administrative Law Course was a highly enriching experience that will contribute meaningfully to the continued excellence of our administrative adjudication processes.

These techniques will also allow me to remain in a position of discernment without allowing the emotional weight of the case to impact my behavior or decision making.

The training was critical to my development as a magistrate judge and the resources provided will give me something to refer back to when issues come up in my cases or hearings. The education I recieved will allow me to more intelligently consider and apply the Judiciairy's mission so that the Court's services will continue to be transparent, inclusive and accessible to all patrons.

I attended the Enhancing Judicial Skills in Abuse in Later Life Cases Workshop (the "Workshop") sponsored by the National Judicial Institute on Domestic Violence through a partnership of Futures Without Violence and the National Council of Juvenile and Family Court Judges.

The Workshop was facilitated by judges and other professionals who work with victims of later life abuse cases. The attendees were all judicial officers as the focus was on the role and duties of a judge in elder abuse cases. The Workshop included daily plenary, or group workshop sessions, as well as smaller group sessions which allowed for role playing and more specific discussions. The topics covered focused on aging and the dynamics of abuse in later life; fact-findings in elder abuse in later life cases; increasing access to justice for victims of elder abuse; and decision-making skills for judges.

As I currently hear cases involving abuse and our elderly population, the Workshop provided me with practical information on how to approach cases and what issues and questions to address when these matters arise in the courtroom. The ability to role-play was especially helpful as it provided the opportunity for judges to rule in hypothetical situations and play the roles, not only of judge, but of attorney and victim when addressing these complex issues.

Thank you for the opportunity to attend the Workshop. Hearing from and conferring with others who work in the areas of domestic violence and elder abuse helps to improve the skills needed to address these issues in the courtroom. The Office of Regulation Counsel, Supreme Court of Guam, is responsible for the enforcement of rules governing disciplinary and disability proceedings of attorneys within the Supreme Court of Guam's jurisdiction and under the Comprehensive Lawyer Regulatory System. These rules include the Guam Rules for Lawyer Disciplinary Enforcement and Disability Proceedings, as well as the Guam Rules of Professional Conduct.

The American Bar Association (ABA) has consistently advocated for and adopted the highest ethical standards within the legal community, promoting legal ethics, professional responsibility, and the rule of law. The 50th ABA National Conference on Professional Responsibility was held on May 28-30, 2025, in Arlington, VA. This Conference offered educational programming and provided opportunities for dialogue on cutting-edge issues in professional responsibility, as well as networking with colleagues in the legal and ethics fields. The Conference contributes to the professional development of legal ethics practitioners, including regulatory and disciplinary counsel from Guam and across the country, and supports the Judiciary of Guam's mission to serve our community more effectively, protect the public's interests, and deliver justice fairly and efficiently through transparent, inclusive, and accessible court services.

The National Conference on Professional Responsibility is the annual educational and networking event for lawyers who represent, prosecute, advise, and educate other lawyers on issues of ethics, discipline, professionalism, and related matters. The Conference explores and debates current issues facing the profession at this national gathering of lawyers, judges, and professors. The speakers are experts in their respective fields and provide the latest information and insights from their dynamic perspective.

At the 50th ABA National Conference on Professional Responsibility. I attended the following educational programming in legal ethics and professional responsibility: Through the Past, Darkly: Explorations Into the Provenance and Virtues of the ABA Model Rules of Professional Conduct, and Auguries as to Their Future (review of the history of the law of lawyering, beginning with the genesis of uniform ethics rules, traversing the development and evolution of the Model Rules, and concluding with forecasts about the future of legal ethics and professional regulation); Is it Time to Reform America's Lawyer Regulatory System? (discussion of major trends requiring a fresh look at lawyer regulation and the need for lawyer regulatory reform); Promoting the Administration of Justice: A Lawyer's Duty? (using Brown v. Board of Education as a backdrop, a discussion of the role that the administration of justice should play in ethical decision making in the work of lawyers, judges, and bar regulators); Conflicts of Interest - A Potpourri (hypotheticals used to discuss a variety of conflict of interest issues under Model Rules of Professional Conduct 1.7 through 1.10); Al: The Next Level (exploring the next level of issues with Al, including (1) Regulation of AI in the U.S. and other countries and how it will impact the practice of law; (2) Deepfakes - how to recognize them; (3) Law firm training of staff on uses and risks of AI; and (4) How to vet an AI vendor and what provisions must be included in a vendor contract; and how to be a competent lawyer (Model Rule of Professional Conduct 1.1) who communicates properly (Rule 1.4) and protects client information and data (Rule 1.6)); Taking Nonlawyer Ownership National: How ABSs May Ethically Extend their Reach Beyond their Home Jurisdictions (review of nonlawyer law firms, or alternative business structures (ABSs), how (and if) they work ethically, what business models are built on them, and whether they are subject to attack as violating the rules and law of other jurisdictions' traditional bans on nonlawyer ownership); Upleveling the Practice Through AI (discussion of current uses and trends with AI in the legal field, the beneficial uses of Al in practice, how to integrate Al into the practice ethically, and what's ahead in this rapidly evolving landscape); Navigating Incivility and Bullying in the Legal Profession (review of data surrounding incivility and bullying in the profession and offer best practices for employers from an internal firm management perspective; and address when and how law enforcement, prosecutors, or disciplinary authorities can help with intimidation, strategies for countering online attacks on one's professional reputation, recognizing volatile situations, advocating for oneself and others when bullying occurs, and safeguarding one's mental health); Breaking Bad (Tech) Habits (learning how cyberattacks occur, how they can be avoided, and how an organization can mitigate its risk); and UPL, Rule 5.4 and the "Lawyer Monopoly": Historical Perspectives (review of the history leading up to and driving the adoption of the rules restricting nonlawyers' involvement in legal services, what these restrictions mean for access to justice today, and what it should mean for the future of legal services regulation).

I had the opportunity to attend the 2025 Society for Human Resource Management (SHRM) Annual Conference & Expo, held from June 29 to July 2, 2025 at the San Diego Convention Center. This flagship HR conference brought together over 20,000 professionals across public and private sectors and offered more than 375 sessions focused on current and emerging issues in human resource management.

The conference featured a wide array of sessions aligned with today's evolving workplace challenges. Topics most relevant to our work within the Judiciary of Guam included:

- 1. Al and HR Technology: Emphasis on ethical frameworks and transparency in using Al tools for decision-making.
- 2, Workplace Compliance and Employment Law: Updated guidance on federal and state labor laws, including harassment prevention, pay transparency, and leave management.
- 3. Workforce Wellness & Retention: Addressed burnout and the need for mental health programs tailored to public-sector employees.
- 4. Diversity, Equity, Inclusion & Belonging (DEIB): Offered frameworks to build inclusive workplace practices and reduce bias in hiring, promotions, and discipline.

The SHRM 2025 Annual Conference provided valuable, forward-thinking insights that directly support our strategic goals. The information obtained is intended to enhance and support my drafting and grading responsibilities. This is important in ensuring the fair evaluation of bar examinees and admission of competent attorneys to the practice of law in Guam.

This is a report on the National Conference of Bar Examiners (NCBE) Annual Bar Admissions Conference, which I, along with others from Guam, attended in Seattle, Washington, from May 1-4, 2025. The conference provided jurisdictions from throughout the nation with critical updates regarding the NextGen Bar Exam and enabled state Supreme Court justices and bar administrators to network and compare how their respective jurisdictions are preparing to implement NextGen, which was especially valuable to Guam as we become one of the first in the nation to administer the NextGen exam in July 2026. I attended the following sessions: Plenary: Who Will Be Tomorrow's Lawyers? 2024 Pipeline Data; NextGen: Where We Are and What's Next; Plenary: Moving Minds: From Research Excellence to Jurisdictional Impact; Navigating Modern Test Accommodation Challenges; Ensuring Candidate Knowledge of Local Law; Mastering NextGen Grading: Item Types and Rubrics; Building an Ethical Profession Through Curriculum Reform; and Plenary: The Al Revolution in Law: Navigating Education, Practice, and Ethics.

The conference provided a better understanding of what is to come with NextGen and what next steps NCBE is taking to gather, analyze, and distribute the data Guam needs to amend our admission rules and prepare for the NextGen exam. During the conference, I networked with several jurisdictions, including Hawaii, Ohio, Texas, Florida, and Saipan, which provided me with insight into how these jurisdictions are preparing for NextGen implementation, as well as what alternative pathways to admission they are exploring or preparing to approve that may work for Guam. Finally, the conference provided valuable insights into the ethical use of AI in legal work and how the employment landscape is shaping bar passage rates and career choices of recent law school graduates.

In the evening on May 8th, the whole team (students, coaches, and myself) all went to the Pin Exchange event where the kids enjoyed exchanging trinkets with other teams from the 47 other states/ territories/ South Korea. The Guam Visitors Bureau provided Guam lapel pins and pens for our kids to exchange with the other teams' kids. Later at the event, they went roller skating at the rink on-site.

May 9th and 10th were tournament days with two rounds each day. The competition was fierce amongst the 48 teams. Guam played well against Texas in Round 1, New Hampshire in Round 2, Ohio in Round 3, and Virginia in Round 4.

The gala awards ceremony took place around 6pm at the Hyatt on May 10th. The Guam team is extremely proud and honored to be this year's recipient of the NHSMTC Larry Bakko Professionalism and Civility Award. I attended the National Conference of Bar Examiners (NCBE) Annual Bar Admissions Conference (ABAC 2025) in Seattle, Washington, from May 1 to 4. This national gathering brought together bar admissions professionals, examiners, educators, and members of the judiciary to discuss the evolving landscape of lawyer licensure and legal education. The sessions I attended were both timely and relevant to the work of the Judiciary of Guam.

Some sessions focused on emerging trends in legal education, bar admissions, and the evolving profile of future lawyers. Discussions highlighted key data on law school enrollment, bar passage, and employment, as well as the increasing role of technology and distance learning in shaping the legal profession. Several sessions explored how courts and licensing bodies can responsibly adapt to innovations such as artificial intelligence and remote proceedings.

These conversations provided useful insights into how technology can expand access to justice while preserving fairness and integrity in judicial processes. Other sessions emphasized the importance of research-based approaches to supporting law students and bar applicants, offering strategies to build motivation, resilience, and practical support systems across jurisdictions.

Throughout the conference, I engaged in discussions with colleagues from across the country on how to apply these insights in a way that strengthens our bar admissions process and better prepares attorneys for the evolving demands of the profession.

The conference provided jurisdictions from throughout the nation with critical updates regarding the NextGen Bar Exam and enabled state Supreme Court justices and bar administrators to network and compare how their respective jurisdictions are preparing to implement NextGen. Guam will become one of the first in the nation to administer the NextGen exam in July 2026. These insights will support our continued efforts to ensure a fair, modern, and accessible bar admissions process for Guam.
