Aguon's 'The Properties of Perpetual Light' earns award for UOG Press

The University of Guam Press won its third Independent Publisher Book Award for "The Properties of Perpetual Light" written by indigenous human rights lawyer and environmental activist Julian Aguon.

The Independent Publisher Book Awards, also known as the IPPY awards, was established in 1996 and has served as the longest and largest running book contest for independent presses.

"The Properties of Perpetual Light" received a gold medal in the category of Best Regional Non-Fiction for Australia, New Zealand, and the Pacific Rim — making this the first gold medal for UOG Press and the book's second national book award. In 2021, the book also won "Best Multicultural Nonfiction" in American Book Fest's Best Book Awards.

"It's an honor to have helped UOG Press win another IPPY award," Aguon said. "I'm just happy that the Press is getting the acclaim it so richly deserves, and I look forward to reading all the other authors whose books are in the works."

Aguon's "To Hell With Drowning" was also selected as a finalist for the Pulitzer Prize for Commentary. The essay was published in The Atlantic last November, and shares the

stories of Indigenous Pacific Island communities fighting against the destruction of climate change to achieve a more hopeful future.

"The Properties of Perpetual Light" will be republished for international distribution by Astra House in New York City under the new title "No Country for Eight-Spot Butterflies." The book is expected for release on Sept. 13 and will include an introduction by Booker Prize-winning author Arundhati Roy and a new afterword by Aguon.

UOG Press will continue to distribute "The Properties of Perpetual Light" on its website and in stores throughout Micronesia.

US forces in Okinawa make presence felt with an eye on China (Japan News) – When U.S. Ambas-

(Japan News) — When U.S. Ambassador to Japan Rahm Emanuel met Okinawa Gov. Denny Tamaki on April 27, he told Tamaki that what Japan and the United States do together will shape the next 30 years in the region surrounding Okinawa Prefecture. Emanuel stressed the significance of deepening the Japan-U.S. alliance with a view to deterring China, saying the two countries have a responsibility to cooperate.

It was the first time in about four years and five months that a U.S. ambassador to Japan had met with the Okinawa governor in the prefecture. Emanuel's visit to the Okinawa prefectural government office three months after arriving to take up his post is perceived as showing that the United States understands the significance of its military bases in the prefecture and the importance of learning about the local community.

The importance of the U.S. military presence in Okinawa is growing. A contingency in the Taiwan Strait has begun to look more and more realistic. The U.S. military is stepping up training based on a new form of expeditionary warfare.

In February, a landing craft approached the U.S. military's Kin Blue Beach Training Area in the town of Kin. A drill was conducted in a setting where a beach here was a

remote island. The boat gliding on the surface of the sea was a U.S. Navy Landing Craft Air Cushion.

With a loud groaning sound, the craft was driven up onto the sandy beach. After landing, the forward part of the craft opened, and a vehicle equipped with a high-mobility rocket launcher system rolled onto land, ready to fire. It took only about five minutes after landing.

The training exercise was premised on securing a base of operations, including the recapture of an occupied remote island. A senior U.S. Marine Corps official who supervised the training said they are very concerned about a Taiwan contingency. The United States is enhancing its capabilities in preparation for any contingency, the official emphasized.

The new type of U.S. military operation is called Expeditionary Advanced Base Operations, or EABO, Small units of highly mobile marines will be dispersed to islands within range of the enemy to establish bases for launching anti-aircraft and anti-ship operations, resupplying and intelligence gathering. EABO includes sea control missions of the U.S. Navy, dealing with the threat of anti-ship

RESOLUTION NO. JC22-

RELATIVE TO APPROVING THE JUDICIARY OF GUAM COMMON AREAS RECORDING POLICY

- WHEREAS, on August 11, 2016, the Supreme Court of Guam issued Promulgation Order No. PRM16-001-01, adopting the Judiciary of Guam Rules Governing Coverage of Judicial Proceedings. Under Rule 3(c), the media may use electronic devices in the common areas of the courthouse, subject to reasonable restrictions that may be put into place by the Judiciary that are appropriate to maintain safety, decorum, and order; and
 WHEREAS, electronic devices with the ability to record audio and video have become widely available, increasing the need for regulations on their usage; and
- WHEREAS, the use of audio and video recording devices can be used in a harassing manner which could compromise the safety and security of Judiciary facilities, and could also be used purposely or inadvertently to record individuals who are entitled to privacy, such as juveniles; and
- whereas a draft Judiciary of Guam Common Areas Recording Policy, which does not apply to audio or video recording of courtroom proceedings, was introduced to the Judicial Council by the Administrator of the Courts during the Judicial Council meeting on March 17, 2022, and circulated to the Bar Association on April 4, 2022; and
- **WHEREAS,** the Judicial Council recognizes the need to maintain integrity, security, and decorum in all Judiciary locations.

NOW, THEREFORE, BE IT RESOLVED that the Judicial Council hereby adopts the Judiciary of Guam Common Areas Recording Policy, attached here at "Attachment 1."

Attachment 1 Judiciary of Guam Common Areas Recording Policy

I. PURPOSE

The Judiciary of Guam (the "Judiciary") institutes this policy as part of its commitment to maintain decorum and order in all Judiciary facilities and to ensure a safe and non-threatening environment for all Judiciary patrons and employees.

II. AUTHORITY

This policy is authorized pursuant to Rule 3(c) of the Judiciary of Guam Rules Governing Electronic Coverage of Judiciary Proceedings, adopted by the Supreme Court of Guam via Promulgation Order No. PRM16-001-01.

III. APPLICATION

This policy shall apply to the common areas in all Judiciary facilities. Common areas include entrances, exits, hallways and spaces that are accessible to the public. This policy shall not apply to the interiors of individual courtrooms, which are specifically covered in the Rules Governing Electronic Coverage of Judiciary Proceedings.

IV. PROHIBITIONS

Except as provided in the Rules Governing Electronic Coverage of Judiciary Proceedings, all audio and video recording by any person in the common areas of Judiciary facilities without the prior consent of the Administrator of the Courts or a judicial officer is prohibited.

This prohibition shall not apply to investitures and other official ceremonies held in the common areas.

V. POSTING OF THIS POLICY

A copy of this policy shall be posted on the Judiciary website, entrances to all Judiciary facilities, Superior Court and Supreme Court Clerk's Offices and at other appropriate public locations at each Judiciary facility as determined by the Administrator of the Courts.

Good day, on one hand I agree with the policy in its entirety because it acts to prevent harassment within the courthouse and generally aims to prevent 'gotcha' moments by people trying to record conversations that may be used against a party (essentially eavesdropping) or an just from being blindsided right outside of court without time and a safe place to regroup before the press tries to get a statement from someone.

It also goes to protecting juror anonymity in high profile cases and prevents the need to use smoke and mirrors to sneak a jury out safely, which certainly is a positive thing and protects against claims of juror intimidation or the unthinkable 'mob style' methods more common in the mainland during prohibition.

The much weaker 'hand' is that allowing for open recording would allow for more transparency as it allows the press/others to show what the courthouse is 'really like' to someone who may not be able or comfortable going to the courthouse (whether from physical disability or things like a 'shy witness')

I am agreeing with the recommendation set forth.

We object in the strongest terms to section IV of the draft Judiciary of Guam Common Area Recording Policy. Audio and video recording in the common areas of the court building do not disrupt any official proceedings. The general public has full access to these areas. There is no compelling reason to limit credentialed media from accessing these same public areas to conduct interviews and take video as necessary to perform their jobs. The court proposes to allow video and audio recording of only select events. This raises a question as to the court's intrusion into free speech, wherein it chooses which events may be covered in a public space.

On behalf of the Pacific News Center I'd like to voice my concern in regard to the proposed common area recording policy.

"Except as provided in the Rules Governing Electronic Coverage of Judiciary Proceedings, all audio and video recording by any person in the common areas of Judiciary facilities without the prior consent of the Administrator of the Courts or a judicial officer is prohibited.

This prohibition shall not apply to investitures and other official ceremonies held in the common areas."

As these are "common areas" and accessible to members of the public, they should not adhere to the same restrictions for the media as other facilities.

The 1st amendment provides that congress make no law respecting an establishment of religion, or prohibiting its free exercise. It protects freedom of speech, the press, assembly and the right to petition the Government for a redress of grievances.

Thank you for requesting comment from the media on the proposal to ban audio and video recording devices in public, common areas of Judiciary of Guam facilities.

The Pacific Daily News opposes this rule.

The "public, common areas" of the Judiciary of Guam are just that – public and common. Under the First Amendment, news media have a right to gather, record and report the events occurring in public, common areas.

News professionals are representatives of the public, recording and reporting the work of the government agencies and institutions that serve the people.

The work of the Judiciary of Guam is of interest to every resident on this island. When people are prosecuted in criminal court, they are prosecuted on behalf of the people.

The disputes of our community are resolved through civil proceedings. Nobody is untouched by the acts of our Judiciary, which wields the power to deprive people of freedom and finances, to interpret the laws we must all live by and to make decisions that affect the lives of the people it serves.

Yet, the news media will be unable to interview attorneys in the hallways of the public, common areas?

We should be encouraging more engagement on behalf of the people, not less access.

Courtroom recordings are at the discretion of a judge. And under this rule, any recordings in public areas would need to be pre-approved by a judicial officer. This rule would not apply to "investitures and other official ceremonies" held in common areas.

Presumably, holiday parties and drug court graduations and other events that the Judiciary chooses to photograph would continue to be recorded and promoted on the Judiciary's social media platforms. But the news media would be prohibited from recording activity associated with more serious cases, or more controversial matters – matters of public interest, being conducted in the name of the public.

The rule is being proposed to "maintain decorum and order" and to "ensure a safe and non-threatening environment" in the public, common areas. Rather than restrict news coverage of matters of public interest being conducted in a public space on behalf of the public by news professionals, we urge the Judiciary to take a different approach.

If this rule is being considered to prevent potential disruptions or unsafe behavior by news professionals, we ask the Judiciary to consider the possible abuses of this rule. What would prevent a judicial officer from restricting recording privileges of an unpopular journalist? Or from allowing interviews with one attorney and not another? Professional ethics? Journalists also have professional ethics.

We ask that you reject this proposed rule. It does not serve the public, it does not serve free speech and ultimately, it is a move against government transparency.

Please accept my response to the draft policy.

I am a Senior reporter with The Guam Daily Post and I have been a journalist for the past 15 years.

I disagree and oppose the proposal to add restrictions for the use of recording devices, specifically by the media in public, common area spaces of the Judiciary. Initially, I questioned why the proposal was brought up to begin with when these are public areas in government building.

I understand there are concerns and issues that might have come up in the past with court patrons, but isn't that why the marshals are there - to ensure the protection and safety of all.

How does limiting a member of the press like myself to freely electronically gather and record events inside the courthouse impact or benefit the community we all serve as a whole?

I ask this council to vote against the proposal as drafted.

This proposal puts in place a perception that the Judiciary does not want to be transparent.

If the council would like to proceed, then may I suggest not including the media in this restriction.

Also, may I request that we no longer be required to submit requests for **nonelectronic** coverage as this was never a requirement before the pandemic.

RELATIVE TO MEMORIALIZING THE PASSING OF ASSOCIATE JUSTICE JOAQUIN C. ARRIOLA, SR.

WHEREAS,	the Judicial Council recognizes with great sadness the passing of Associate Justice Joaquin C. Arriola, Sr. on May 4,
	2022; and

- WHEREAS, Associate Justice Arriola dedicated nearly 70 years to the practice of law, retiring only in January of 2021 as recognized by this Judicial Council in Resolution No. JC21-001 commending his decades of service to the legal profession and people of Guam; and
- WHEREAS, Associate Justice Arriola survived the Japanese occupation of Guam in World War II to become one of Guam's first Chamorro lawyers and forefathers to the practice of law in Guam; and
- WHEREAS, Associate Justice Arriola's legal career started as a graduate of the University of Minnesota Law School in 1953 and admission that same year to the Supreme Court of Minnesota, the District Court of Guam, the Island Court of Guam, and subsequent admission to the United States Court of Appeals for the Ninth Circuit, the United States Supreme Court, and the Island and District Courts of the Commonwealth of the Northern Mariana Islands; and
- WHEREAS, Associate Justice Arriola founded the Arriola Law Firm—Guam's oldest established law office—and carried on by his daughter, Anita P. Arriola, Esq., and son, Joaquin C. Arriola, Jr. Esq.; and
- WHEREAS, Associate Justice Arriola served his fellow attorneys as a distinguished member and former president (1956-1957) of the Guam Bar Association and member of the Commonwealth of the Northern Mariana Islands Bar Association; and
- WHEREAS, Joaquin C. Arriola, Sr. served the Supreme Court of Guam as a part-time Associate Justice from 1996-1999; and
- WHEREAS, in addition to the practice of law, Associate Justice Arriola served the people of Guam as a senator in the Third and Fourth Guam Legislatures, Speaker in the Ninth and Tenth Guam Legislatures, and Legislative Counsel and Parliamentarian for the Fifth, Sixth, and Seventh Legislatures, wherein he was instrumental in passing laws establishing and organizing Guam's legal system and the courts of Guam; and
- WHEREAS, Associate Justice Arriola also served the Guam community through his work on many boards and commissions and as legal counsel to many Government of Guam agencies; and
- WHEREAS, Associate Justice Arriola received numerous honors throughout his career including earning a Doctor of Laws (*Honoris Causa*) from the University of Guam in 2007, the Guam Judiciary Hustisia Award in 2014, and the Judge Cristobal C. Duenas Excellence Award in 2017; and
- WHEREAS, Associate Justice Arriola will always be held in the highest esteem by the members of our legal profession—practitioners and judicial officers—and will be fondly remembered as a zealous advocate for his clients, while being an utmost professional and respectful officer of the court, advancing and protecting the interests of justice and the rule of law.

NOW THEREFORE BE IT RESOLVED, that the Judicial Council, on behalf of the entire Judiciary of Guam, expresses our sincere condolences and gratitude to the family of the late Associate Justice Joaquin C.
