MINUTES

The Regular Meeting of the Judicial Council was called to order by the Chairman, Chief Justice Robert J. Torres, at the hour of 12:00 p.m.

II. PROOF OF DUE NOTICE OF MEETING

Due publication of the five-day Notices of Meeting of the Judicial Council, as required under the Open Government Law, was published in the Guam Daily Post. Acknowledgments are on file.

III. DETERMINATION OF QUORUM

Chief Justice Torres began the roll call. Chief Justice Robert J. Torres, Presiding Judge Alberto C. Lamorena III, and Judge Maria T. Cenzon identified themselves. Justice F. Philip Carbullido and Justice Katherine A. Maraman were excused. This meeting determined a quorum with three (3) of the five Judicial Council members present during roll call.

IV. READING AND DISPOSAL OF MINUTES: May 15, 2025 Regular Meeting minutes.

Chief Justice Torres asked for a motion to approve the May 15, 2025 Regular Meeting minutes. Presiding Judge Lamorena made a motion to approve the minutes, Judge Cenzon seconded the motion. Chief Justice Torres called an oral vote. With no discussion, the Judicial Council members voted to approve the minutes, subject to correction.

V. OLD BUSINESS

A. Judiciary FY25 Remittances Pursuant to Applicable Law

Ms. Dianne Gudmalin, Finance Administrator, reported that the Judiciary continues to receive its scheduled biweekly allotment of \$1,652,000 for general operations under the FY2025 appropriation. According to Ms. Gudmalin, to date, approximately 73% of the total appropriated amount has been received with the most recent allotment deposited on Monday, June 9, with the next allotment expected on June 24.

B. eCourt and eSupervision Transition

Administrator of the Courts, Danielle T. Rosete, provided an update regarding eCourt and E-Supervision. Ms. Rosete reported that Journal Technologies team members were on-site last week to continue the E-Supervision migration, including meetings to review workflows for probation and client services. She added that for eCourt, a dedicated project manager has been assigned and is working with the Judiciary to assess progress and establish a realistic go-live timeline. Ms. Rosete shared that the team remains committed to launching this year, with staff reassigned as needed to support the project. According to Ms. Rosete, weekly meetings and ongoing communication with Journal Technologies are helping to drive progress.

VI. NEW BUSINESS

A. Resolution, JC25 – Relative to Amending Special Process Server Regulations

Under New Business, the Council considered a resolution proposing amendments to the Special Process Server Regulations. The amendments include recommendations to the Supreme Court to adopt revised rules and to revise associated fees. Proposed changes include maintaining the \$300.00 initial filing fee, introducing a \$150.00 annual renewal fee, and increasing the training fee from \$50.00 to \$75.00. The revisions were previously circulated to the Guam Bar with no comments received.

Presiding Judge Lamorena moved to approve the resolution recommending that the Supreme Court adopt the amended rules and fee schedule as presented in Exhibit A. The motion included that the revised fees would become effective upon the Supreme Court's adoption of the amended regulations. Judge Cenzon seconded the motion; the motion passed unanimously.

B. Resolution, JC25 – Relative to Adopting a Training Program for Special Deputy Marshals

The Council then discussed a second resolution concerning the training program for Special Deputy Marshals deputized from the Department of Revenue and Taxation and the Department of Education. The proposed program was developed in consultation with the POST Commission. Questions were raised about the scope of authority for these officers, particularly regarding their ability to effectuate arrests in truancy and juvenile matters. **The Council agreed to table the resolution until the next meeting, to allow further legal review and consultation** with the Marshal's Division regarding the statutory authority, training frequency, and potential expansion of duties.

C. Notice of the Next Meeting (Thursday, July 17, 2025)

Chief Justice Torres noted that the Council's next meeting will be held on Thursday, July 17, 2025.

 - The initiative aims to educate high school students on the Organic Act and its impact on civil rights.
 - GBA requested the Judicial Council's co-partnership in this outreach, similar to past Constitution Day efforts.

• NAPABA Conference Participation:

- o GBA will present at the NAPABA Conference in November, in collaboration with Fordham University.
 - The CLE topic will address birthright citizenship and its implications for U.S. territories.

NOW THEREFORE, BE IT RESOLVED that the Training Program for Special Deputy Marshals, which is attached as an Exhibit hereto, is adopted by the Judicial Council.

MANDATORY TRAINING PROGRAM (TITLE 27 GCA, CH 3, 3106(2))

RELATIVE TO PEACE OFFICER, CATEGORY II LAW ENFORCEMENT FOR SPECIAL DEPUTIZED MARSHALS

I. Introduction:

The Judiciary of Guam is committed to the continued growth and professional development of Special Deputy Marshals, as authorized under Title 7, Chapter 8 of the Guam Code Annotated (GCA). Under this provision, and at the request of the Marshal of the Courts, the Chief Justice may appoint as Special Deputy Marshals certain employees of:

- A. Department of Revenue and Taxation (DRT); and
- B. Department of Education (DOE), specifically, School Attendance Officers (SAOs).

In accordance with 7 GCA §8107(b) SAOs must complete a training program developed and adopted by the Judicial Council that is pertinent to their appointment, prior to such appointment as Special Deputy Marshals of the Guam Judiciary.

The Judiciary of Guam is further guided by 27 GAR §3103(b)(2), which identifies Special Deputy Marshals as Category II Peace Officers. These rules outline the minimum training standards for Category II Peace Officers, including:

- A. Certificate of In-Service Training approved and certified by the P.O.S.T. Commission
- B. Completion of any other required training directed by the P.O.S.T. Commission.

In coordination with the Guam Peace Officer Standards and Training Commission (P.O.S.T. Commission), the Judiciary developed the following training program to support the preparation and certification of Special Deputy Marshals pursuant to Title 7, Chapter 8 of the GCA. The While the P.O.S.T. Commission has recognized the Judiciary's Marshal's Training & Staff Development Section (T&SDS) as a qualified provider for core as possessing the expertise necessary to conduct certified—in-house training, additional training may be offered through other government entities or institutions, such as To supplement this program, the P.O.S.T. Commission has also recommended that the Guam Community College (GCC), Guam Behavioral Health and Wellness Center (GBHWC),—and the Department of Integrated Services for Individuals with Disabilities (DISID), provide specialized in service training particularly in areas where the Judiciary does not currently hold certifications.

II. Roles and Responsibilities of Special Deputies:

Under Title 7, Chapter 8 of the Guam Code Annotated (GCA), the Chief Justice is authorized to appoint special deputy marshals from designated government agencies for specific judicial functions.

Although classified as Category 2 Peace Officers under 27 GAR § 3103(b)(2), these special deputies perform duties that are narrowly defined and specialized in nature. Their authority is expressly limited by law to functions directly related to their agency roles—such as tax and revenue matters for Department of Revenue and Taxation personnel, and truancy enforcement for School Attendance Officers.

A. Department of Revenue and Taxation

Pursuant to 7 GCA § 8108(b), employees of the DRT who are granted special appointments as deputy marshals shall exercise their authority solely in matters concerning the income tax laws and other tax and revenue laws of Guam.

This limitation means that their authority under the special appointment is limited to functions that directly support the mission and operations of the DRT and may not be exercised beyond those responsibilities.

This applies to the following positions:

- Revenue Officers
- Collection Agents
- Tax Collection Supervisors
- Tax Enforcement Program Administrator

Individuals in these roles may be assigned duties under their special appointment that align with their official job responsibilities as determined by DRT. These duties may include, but are not limited to:

- Administrative enforcement actions;
- Investigative activities; and
- Field support related to agency operations.

The special appointment does not confer general law enforcement powers and shall only be exercised within the scope defined by the agency and applicable law.

—B.Department of Education

Pursuant to 7 GCA § 8108(c), School Attendance Officers of the Department of Education who are granted special appointments as deputy marshals under § 8107 shall exercise their authority only in matters concerning truancy proceedings of the Superior Court of Guam.

This limitation means that their authority under the special appointment is limited to truancy-related functions and may not be exercised beyond those responsibilities.

This applies specifically to School Attendance Officers serving in this capacity. Duties performed-under this special appointment must remain consistent with their assigned job responsibilities as determined by DOE. These may include, but are not limited to:

- Conducting follow-up and fieldwork related to student attendance matters;
- Supporting enforcement of court directives specific to truancy cases;

- Monitoring and reporting compliance with truancy-related conditions;
- Providing field assistance in truancy apprehensions as authorized by law;
- Maintaining case documentation and communicating progress with appropriate stakeholders.

The special appointment does not confer general law enforcement authority and must be exercised strictly within the limits set by the agency and applicable law.

III. Roles and Responsibilities of Employers:

By offering this training program, the Judiciary of Guam does not assume any responsibilities or obligations that rest with the participating agencies. Each employer remains solely responsible for determining the eligibility and continued employment of their personnel in accordance with applicable local and federal laws, as well as relevant regulations, including those established by the Guam P.O.S.T. Commission.

All participating agencies and individuals, including SAOs from the Department of Education and Compliance Officers and Collection Officers from the Department of Revenue and Taxation, shall indemnify and hold the Judiciary of Guam harmless from any and all claims, liabilities, or causes of action for damages, including but not limited to personal injury or death, incurred by the employer, individual, their agents, or any third party during the course of the training provided under this program.

IVH. Category II Peace Officer Training Requirements:

A. Special Deputy Oath

Each individual is appointed on an annual basis and must renew their **Certificate of Oath** each year. To be eligible for renewal, individuals must provide proof of valid certification showing completion of the required training program listed below.

Unless otherwise specified by the training program, such as the First Aid, CPR, and AED certification, which is valid for two (2) years, individuals are required to complete the listed training every three years to maintain eligibility for reappointment.

IV. Category 2 Peace Officer Training – In person and Virtual:

Where feasible, the Marshals TS&DS will collaborate with the Judiciary's Judicial Educator to coordinate with other government trainers to provide virtual certified training for participants in courses that may not require in-person attendance.

VI. Termination of Appointment:

The Chief Justice may revoke a Special Deputy Marshal appointment if the appointee fails to complete the required training and does not maintain certification as mandated or upon separation from their employer, whichever is earlier.

VII. Administrative Authority:

The Administrator of the Courts shall have the discretion and authority to resolve issues not expressly covered herein.

BEFORE THE 2025 JUDICIAL COUNCIL OF GUAM RESOLUTION NO. JC25-012

RELATIVE TO COMMEMORATING THE FIFTIETH ANNIVERSARY OF THE GUAM PUBLIC DEFENDER SERVICE CORPORATION

- WHEREAS, it is the mission of the Public Defender Service Corporation (PDSC) to provide effective legal assistance to those unable to afford private counsel, thereby ensuring equal protection of their lawful rights, in accordance with prescribed ethics, laws, rules and regulations; and
- WHEREAS, the PDSC traces its origins to the Judicare Program, established on September 25, 1968, under the Department of Public Health and Social Services; this early initiative included a Public Defender, an Attorney II, an Administrative Law Secretary, a Special Investigator, and a General Helper, and was created to provide legal advice and representation to indigent individuals in civil, criminal, and juvenile matters; and
- WHEREAS, on March 30, 1972, Guam Public Law No. 11-128 established a separate Office of the Public Defender, providing for the appointment of the Public Defender by the Governor of Guam and authorizing the Public Defender to hire staff necessary to fulfill the office's mission; and
- WHEREAS, on July 10, 1975, Public Law No. 13-51, known as the "Public Defender Service Corporation Act," was enacted to institutionalize and strengthen access to legal representation for those unable to afford counsel; the law created the PDSC as an autonomous corporation whose director would account to a Board of Trustees, thus imbuing the PDSC with further autonomy and independence; and
- WHEREAS, the PDSC has operated in this last half century by providing legal counsel to innumerable criminal defendants, thus reflecting the commitment of the government of Guam to the constitutional requirement that no single individual must stand accused by the state without counsel as mandated by the United States Supreme Court in Gideon v. Wainwright, 372 U.S. 335 (1963); and
- **WHEREAS**, a fair and impartial justice system is the foundation of a healthy democracy, and the work of the PDSC continues to serve as a cornerstone of that foundation; and when the rights of those who cannot afford an attorney are defended, we strengthen the promise of justice for all; and

NOW, THEREFORE, BE IT RESOLVED that the Judicial Council hereby commends the attorneys, staff, and leadership of the Guam Public Defender Service Corporation—past and present—for fifty years of service, dedication, and commitment to protecting the rights of the people of Guam and to advancing justice through equal representation.

- WHEREAS, community corrections professionals are agents of change and work towards the goal of rehabilitation utilizing evidence-based programs and effective supervision to enhance justice-involved individuals' both youth and adults ability to be positive and engaging citizens who make meaningful contributions to our island; and
- WHEREAS, community corrections professionals have been an integral part of the Judiciary of Guam since the 1970s, and they keep the courts informed of the conduct and condition of each probationer under their supervision.

RESOLUTION NO. JC25-017

RELATIVE TO COMMEMORATING THE SEVENTY FIFTH ANNIVERSARY OF THE ORGANIC ACT OF GUAM AND RECOGNIZING ITS FOUNDATIONAL ROLE IN THE ESTABLISHMENT OF GUAM'S JUSTICE SYSTEM

- WHEREAS, on July 1, 1950, President Harry S. Truman signed the Organic Act of Guam into law, establishing Guam's civil government and granting U.S. citizenship to the people of Guam; and
- WHEREAS, the passage of the Organic Act was a defining moment in the island's pursuit of self-governance, ending decades of U.S. naval administration and laying the groundwork for a civilian government composed of a legislative branch, an executive branch, and the framework for a judiciary; and
- WHEREAS, at the time of its passage, the Organic Act vested judicial authority in the federal District Court of Guam, granting it the jurisdiction of other U.S. district courts along with such appellate jurisdiction as the Guam Legislature might determine; and
- WHEREAS, it was not until the Court Reorganization Act of 1974 that the Superior Court of Guam was established as the island's trial court, and the 2004 amendments to the Organic Act confirmed the Supreme Court of Guam as the highest court in the territory—free from federal oversight and equal in authority to its state counterparts; and
- WHEREAS, these advances would not have been possible without the foundation laid by the Organic Act; and
- WHEREAS, although the people of Guam have twice undertaken efforts to draft and ratify a local constitution, these efforts were ultimately unsuccessful and the Organic Act continues to serve as the island's foundational legal framework; and
- WHEREAS, the Judiciary of Guam interprets the Bill of Rights contained in the Organic Act independently, in ways that reflect Guam's unique history, culture, and values; and
- WHEREAS, in *People v. Adriatico* (2024), the Supreme Court of Guam reaffirmed its authority to give fuller effect to the protections enshrined in the Organic Act, reflecting the island's distinctive identity and aspirations for justice; and
- WHEREAS, the Judiciary of Guam remains steadfast in its commitment to safeguard the Organic Act's promises and expand its meaning in service to the people of Guam;

NOW, THEREFORE, BE IT RESOLVED that the Judicial Council of Guam hereby commemorates the Seventy-Fifth Anniversary of the Organic Act of Guam and recognizes the foundational role it has played in the establishment and development of Guam's justice system; and

BE IT FURTHER RESOLVED that the Judicial Council extends its appreciation to all who have contributed to the advancement of justice under the Organic Act and reaffirms the Judiciary's commitment to upholding its principles and expanding its meaning for generations to come.
