## **Guam Mock Trial Champion Okkodo High School Headed to Nationals with Courtroom Artist and Journalist Winners**

*Hagåtña*, Guam – Following the victory of Okkodo High School in the final match of the Guam High School Mock Trial Competition (GHSMTC) on January 22, the Mock Trial Bulldogs will now advance to the National High School Mock Trial Championship in Phoenix, Arizona, where they will represent Guam alongside teams from across the United States, the Northern Mariana Islands, and South Korea.

Courtroom Artist winner Tetin Deleon Guerrero from Father Dueñas Memorial School and Courtroom Journalist winner Giada Sachi Meno from the Academy of Our Lady of Guam will also compete at the national level with the mock trial team. A series of educational sessions and activities will be held locally and in Phoenix, Arizona to prepare for the competition and further develop the team's skills and readiness.

"The Guam High School Mock Trial Competition plays a crucial role in shaping the future leaders of our legal community," said Danielle T. Rosete, Administrator of the Courts. "Through this program, students gain invaluable experience in legal reasoning, public speaking, and teamwork—skills that will serve them well in any career they choose."
